The Work to be performed is located in unincorporated Palm Beach County, and consists of furnishing all labor, tools, materials, and equipment necessary for a complete installation as shown on the Contract Plans and Specifications and as specified herein to include:

MASTER LIFT STATION NO. 1 REHABILIATION

The Work under this project consists of the rehabilitation of Master Lift Station No. 1 which is a domestic wastewater pumping facility owned and operated by the Loxahatchee River Environmental Control District (District). The project Work scope generally includes the supply and install of three (3) new, replacement 110-HP dry-pit, non-submersible type pumps; replacement of the existing pump discharge piping, fittings and valves including a new backup pump connection and below grade vault; replacement of the existing 20-HP emergency dry-pit sump pump; construction of a new below grade metering facility and associated vault; supply and install of a new, replacement prime 350 kW diesel driven emergency generator with sound/weather attenuating enclosure; rehabilitation and recoating of the interior of the lift station building as well as the required upgrades to the existing site electrical and instrumentation and control (I&C) systems.

The District reserves the right to determine material elements of the Bid and to award the Contract, if at all, to the lowest, qualified, responsive, and responsible Bidder. The District further reserves the right to reject any and all Bids; to not proceed with the Project; and/or to waive any irregularities contained in a Bid.
