- 1. Introductions:
 - Owner Loxahatchee River Environmental Control District
- 2. Non-Mandatory Meeting:

- 3. Intent:
 - Inform bidders about project. Point out items of interest and ensure bidders understand what the project entails.
 - Nothing said in this meeting changes the Bidding Documents. Bid what you see.
- 4. Scope: It is the District's intent and the purpose of these specifications to secure licensed electrician services on an as needed basis for general repairs and maintenance to District wastewater and reclaimed water infrastructure, administration/office facilities and environmental education facilities. Work may include but not be limited to permitting, troubleshooting, installation of conduit, cable, switches, receptacles, lighting, breakers, disconnects, meter cans, junction boxes, power and control panels, radio telemetry units, motor control centers and the like. All work shall be in compliance with the solicitation documents, the Loxahatchee River District Manual of Minimum Construction Standards and Technical Specifications (refer to Exhibit A included herein), all applicable local, state and Federal laws and regulations including the Occupational Safety and Health Act Administration (OSHA), including all costs of permits and cost of regulatory compliance. Additionally, this contract includes as-needed on-call or emergency services that will utilize the labor and equipment rates included in this contract with a 1.5 multiplier for labor and equipment only. Materials and sub-contractor work shall be paid on cost plus 15% mark-up basis for all work items.
- 5. Contract Time
 - Refer to Special Conditions 4. Method of Ordering (Term Contract). Contract shall be issued for a term of twelve (12) months, with four possible 1-year extensions.
- 6. Qualifications
 - State of Florida Certified Electrical Contractor
 - 5 references where similar goods and services have been provided in past 5 years.
- 7. Standards and Specifications
 - All work shall comply with Loxahatchee River Environmental Control District's Manual of Minimum Construction Standards and Technical Specifications
