WITNESSETH: That whereas the District has awarded to Contractor the Work of performing certain construction:

<u>SECTION 1</u>. Scope of Work: Contractor shall furnish, install and deliver all of the labor, including engineering design, materials (except District-furnished materials), tools, equipment, services, and everything necessary to perform the Work; and shall construct in accordance with the Contract Documents and the terms of this Contract, the Project known and identified as COUNTY LINE ROAD RECLAIMED WATER MAIN, WATER MAIN AND RAW WATER MAIN RELOCATION and shall do everything required by or reasonably inferable from the Contract Documents. The Work is generally described as follows:
